- ◆ Minimum of 20 amp services for boats on the water (do not order 10 amps on docks)

5. All equipment, regardless of source of power, must comply with the National Electrical Code, as well as all federal, state and local safety codes.
6. All equipment must be UL-listed or certified by a nationally recognized testing laboratory.
7. All electrical equipment must have provisions for grounding. No two-conductor cords may be used.
8. Exhibitor holds TSE and Duncan McIntosh Co. Inc. harmless from any and all losses of power including but not limited to losses due to utility company failure, permanent power distribution failure, power failure caused by vandalism, faulty exhibitor equipment or overloads caused by exhibitor.
